Demand for an Immediate Injunction Against Quarantining/Detention and Mandatory Vaccines

We, the people of the united States of America are demanding an immediate injunction against any and all quarantining and mandatory vaccination of the American people because in the unseen context of such orders, as will be shown below, they are in no way health measures, they are unquestionably unconstitutional, they are tied to a plan to end the US as a sovereign country and bring in foreign troops, and they are an immediate and blatant genocidal threat to the lives of millions of Americans, men, women and children.

Here are the reasons which rest on legal, medical, historical and criminal information:

- 1. Quarantining and mandatory vaccination rest upon two intersecting orders signed by George W Bush in 2007 with neither voted on by Congress.
- 2. Goerge W. Bush signed a Presidential Directive on May 9, 2007 under which gives the White House unprecedented dictatorial power over the government and the country, bypassing the US Congress and obliterating the separation of powers. The directive also places the Secretary of Homeland Security in charge of domestic "security".

After receiving concerned communications from constituents, in July 2007 U.S.

Representative and Homeland Security Committee member Peter DeFazio made an official request to examine the classified Continuity Annexes in a secure "bubbleroom" in the United States Capitol, but his request was denied by the White House, which cited "national security concerns."[8] This was the first time DeFazio had been denied access to documents. He was quoted as saying, "We're talking about the continuity of the government of the United States of America...I would think that would be relevant to any member of Congress, let alone a member of the Homeland Security Committee."[8] After this denial, DeFazio joined with two colleagues (Bennie Thompson, chairman of the committee; and Chris Carney, chairman of the Homeland Security oversight subcommittee) in a renewed effort to gain access to the documents.

3. Also in 2007, Bush put into force International Health Regulations which stipulate that in the event of the declaration of a global pandemic emergency, the UN and the WHO will take control of the country, along with DHS and FEMA. In Europe, the WHO and NATO would take control.

There regulations raises the issue regarding separation of powers, as **the authority to enter into** international treaty is solely held to the federal government and expressly prohibited to the states.

- 4. Between the two orders, neither voted on by Congress, the mere declaration by the WHO of a "pandemic emergency," if the president also declares such an emergency, those declarations trigger two things 1). the end of Constitutional government in the US with control of the country ceded to a president ruling alone, with support from DHS, and 2) for two foreign entities, the WHO and UN troops, to enter the US, and side by side with a now massively armed DHS and FEMA, take control in the US.
- 5. Of note, there is no provision in Bush's presidential directive for reinstating the Constitution or in the International Health Regulations (IHR) for calling off the emergency and pulling UN troops and WHO out of the US. And DHS has been massively armed and FEMA has built over 300 "camps" which resemble concentration camps (barbed wire facing in, train tracks running into the camps, etc.) and has had boxcars with shackles since 2011 and with guillotines mounted at the front of them.
- **6.** The WHO's IHR are the legal framework for quarantining and mass vaccinating people across the USA. The WHO"s IHR, signed by Bush without Congressional vote, arranges for a foreign entity, merely on that foreign entity's declaration of an emergency, to subject the United States to martial law control by that foreign entity and backed up by foreign (UN) troops on US soil.
- 7. Quarantining and mandatory vaccination thus arise from two unconstitutional sources a Presidential directive that arranges for the end of Constitutional government in the US in the event of a catastrophic emergency, and the intersection with a second unconstitutional agreement between a president and a foreign power/entity, the WHO, which by that entity's mere declaration of a catastrophic pandemic emergency, would include a military invasion of the US by UN troops and WHO. This would bring about the end of constitutional rule in US as stipulated by the same president, "in the event of an emergency" with no provisions for reinstating it.
- 8. In both cases, quarantining and mandatory vaccination arise from treasonous acts by George W. Bush that 1). arrange for the end of the US Constitution and rule by representative government, and 2). the invasion of the US by foreign troops.
- 9. These unquestionably treasonous acts are reinforced by the Homeland Security Act (HSA) which was pushed through Congress after 9/11 and by the Model State Emergency Health Powers Act (MSEHPA, MEHPA, or EHPA) pushed state legislatures following the anthrax killings. They hand immense power over to the CDC and HHS, providing opportunity for forced vaccinations of the entire public as well as other unspecified forms of medical intervention "deemed necessary in a health emergency" as defined by a health official, who is appointed to office. HHS will oversee all states in establishing and directing a health emergency, which can be merely the "potential "of a health emergency. A section of a MSEHPA law in Massachusetts is included with the Evidence provided, which shows it to be thinly disguised martial law and dovetailing with a military take over of the US as it lists seizure of fuels, communication, transportation, food, clothing and more.
- 10. The findings of Congress' Committee for Governmental Reform in 1999 found numerous

problems with the CDC, which was instrumental in aiding the passage of the MSEHPA (this is take from an article included with the Evidence portion of this demand for an immediate injunction):

- * The CDC routinely granted waivers from conflicts of interest rules to every member of its advisory committee.
- * CDC advisory committee members who were not allowed to vote on certain recommendations due to financial conflicts of interest, were allowed to actively participate in committee deliberations and advocate specific positions.
- * The Chairman of the CDC's advisory committee until recently owned 600 shares of stock in Merck, a pharmaceutical company with an active vaccine division.
- * Members of the CDC's advisory committee often left key details out of their financial disclosure statements, and were not required to provide the missing information by CDC ethics officials.
- *On June 15, 2000, further hearings by this committee again revealed a conflictof interest with the CDC Advisory committee and the Pharmaceutical companies.
- *These conflicts still exist today, as seen in the recent hearings of this committee on Dec. 10, 2002. At these hearings, **Representative Dan Burton (R.-TX) ripped the CDC and National Institute for Health (NIH) for not recalling dangerous vaccines**, and for their reluctance (resistance, if you will) to act in the public's best interest4,5
- 10. Elements of MSEHPA violate the first, fourth, fifth, sixth and eighth amendments to the Constitution and treat American citizens as if they are the enemy. This is consistent with a health "emergency" actually being used as a cover for a military take over.
- 11. Who runs the World Health Organization?
 The main funders of the WHO are the Rockefellers and Bill Gates.

The Rockefellers had half interest in IG Farben, the Germany pharmaceutical and chemical consortium that funded Hitler, http://www4.dr-rath-foundation.org/

"This is the very same WHO that unilaterally declared a pandemic level 6 emergency in 2009 after altering the definition of pandemic several times until it was loose enough to allow it to declare just such an pandemic emergency, allowing it to impose martial law, quarantines and forced vaccinations on the world.

- 12 . Barack Obama campaigned on a pledge to immediately overturn all of Bush's executive orders and not write any himself, but he did not overturn any of Bush's orders or directives and has added many himself. Most relevant to quarantining and mandatory vaccination, Obama's most recent Presidential order, *Revised List of Quarantinable Communicable Diseases*, amends executive order 13295, passed by George W. Bush in April 2003, which allows for the, "apprehension, detention, or conditional release of individuals to prevent the introduction, transmission, or spread of suspected communicable diseases." Obama's order lowered the bar for detaining Americans and subjecting them to detention (quarantine) which is expected to include forced vaccination. He reduced the standard to a mere respiratory illness as a means of forcibly detaining any American, such that a cold could be used to forcibly detain people. The order is included in the Evidence.
- 13. The acceptance of a "pandemic emergency" which is the only basis for the quarantining of US citizens and mandatory vaccination **coincides with and thus becomes de facto acceptance of**
- a. a full dictatorship in the US as arranged in great detail by George W. Bush by means of National Security Presidential Directive/NSPD 51 and Homeland Security Presidential Directive/HSPD-20, neither voted on by Congress, and

- b. an invasion of the US by foreign troops (the UN).
- c. control of the US by a foreign entity (the WHO).

Such emergency powers are entirely unconstitutional and thus so are any and all quarantining and mandatory vaccination under a "pandemic emergency" which is actually the trigger for 1), 2), and 3).

- 14. The bases for the Homeland Security itself and for pandemic laws which include mass quarantining and mandatory vaccination were both false flag attacks on the US that have each been proven.
- 15. 16. An investigation proved the anthrax for the murders originated at the U.S. Army Medical Research Institute of Infectious Diseases (USAMRIID) at Fort Detrick, Maryland a bioweapons lab. A scientist, microbiologist Bruce Edward Ivins, who had worked there for 25 years and had no political history of activism, was blamed and immediately afterwards "committed suicide." The case was shut down but as with the government's 9/11 investigation, questions were not answered.

The militarized anthrax used by the US was developed by William C. Patrick III, who holds five classified patents on the process. He has worked at both Fort Detrick, and the Dugway Proving Grounds in Utah. Patrick is now a private biowarfare consultant to the military and CIA. Patrick developed the process by which anthrax spores could be concentrated at the level of one trillion spores per gram. No other country has been able to get concentrations above 500 billion per gram. The anthrax that was sent around the eastern US last fall was concentrated at one trillion spores per gram, according to a Jan. 31 report by Barbara Hatch Rosenberg of the Federation of American Scientists. http://www.rense.com/general20/mic.htm

17. As many as 15 world-class microbiologists have died between 9/11/01 and 6/24/02. http://www.rense.com/general20/mic.htm The scientists were involved in DNA sequencing and in bioweapons research.

*Set Van Nguyen was found dead on Dec. 11 at the Commonwealth Scientific and Industrial Research Organization's animal diseases facility in Geelong, Australia. He had worked there 15 years. According to an article on www.rense.com by Ian Gurney, in Jan. 20001 the magazine Nature published information that two scientists at this facility, using genetic manipulation and DNA sequencing, had created an incredibly virulent form of mousepox, a cousin of smallpox. The researchers were extremely concerned that if similar manipulation could be done to smallpox, a terrifying weapon could be unleashed.

*In 1989, Vladimir Pasechnik defected from the Former Soviet Union (FSU) to Great Britain while on a trip to Paris. He had been the top scientist in the FSU's bioweapons program, which is heavily dependent upon DNA sequencing. Pasechnik's death was reported in the New York Times as having occurred on Nov. 23. Pasechnik had formed a company called Regma Biotechnologies Ltd. Regma describes itself as "a new drug company working to provide powerful alternatives to antibiotics." Like three other microbiologists detailed in this article, Pasechnik was heavily involved in DNA sequencing research. During the anthrax panic of this past fall, Pasechnik offered his services to the British government to help in any way possible.

*Victor Korshunov was head of the microbiology sub-facility at the Russian State Medical University. He was found dead in the entrance to his home with a cranial injury. Pravda reports that Korshunov had probably invented either a vaccine to protect against biological weapons, or a weapon itself.

*A newspaper in Norwich, England reported the previous day's death of Ian Langford, a senior researcher at the University of East Anglia. The story went on to say that police "were not treating the death as suspicious." The next day, Britain's The Times reported that Langford was found wedged under a chair "at his blood-spattered and apparently ransacked home."

*There is another intriguing connection between three of the five American scientists that have died. Wiley, Schwartz, and Benito Que worked for medical research facilities that received grants from Howard Hughes Medical Institute (HHMI). HHMI funds a tremendous number of research programs at schools, hospitals and research facilities, and has long been alleged to be **conducting** "black ops" biomedical research for intelligence organizations, including the CIA.

Long-time biowarfare investigator Patricia Dole, Ph.D. reports that there is a history of people connected to HHMI being murdered. In 1994, Jose Trias met with a friend in Houston, Texas and was planning to go public with his personal knowledge of HHMI "front door" grants being diverted to "back door" black ops bioresearch. The next day, Trias and his wife were found dead in their Chevy Chase, Md. home. Chevy Chase is where HHMI is headquartered. Police described the killings as a professional hit. Tsunao Saitoh, who formerly worked at an HHMI-funded lab at Columbia University, was shot to death on May 7, 1996 while sitting in his car outside his home in La Jolla, Calif. 18. The military contractor Dyncorp, Hadron, Promis Software & Disease Research. Dyncorp holds a patent on the H1N1 virus (swine flu). It was patrolling in helicopters along the Mexico/US border where swine flu first broke out, and is involved in human slavery. In a lawsuit filed by a former employee in 1999:

Ben Johnston, a <u>DynCorp</u> aircraft mechanic for Apache and Blackhawk helicopters in Kosovo, filed a lawsuit against his employer. The suit alleged that that in the latter part of 1999 Johnson "learned that employees and supervisors from <u>DynCorp</u> were engaging in perverse, illegal and inhumane behavior [and] were purchasing illegal weapons, women, forged passports and [participating in] other immoral acts."

"DynCorp is just as immoral and elite as possible, and any rule they can break they do," Johnston told Insight magazine. He charged that the company also billed the Army for unnecessary repairs and padded the payroll. "What they say in Bosnia is that DynCorp just needs a warm body -- that's the DynCorp slogan. Even if you don't do an eight-hour day, they'll sign you in for it because that's how they bill the government.

- 19 "The research the microbiologists were doing could have developed methods of treating diseases like anthrax and smallpox without conventional antibiotics or vaccines." The Kenema bioweapons lab is the only testing centre for ebola in Sierra Leona and holds the highest number of victims.
