Four Island Vaccination Genocide Media Advisory - Tribunal Orders Cease and Desist of Genocidal COVID Vaccinations on the Four Island Nations. COVID Vaccinations had been made mandatory or necessary conditions of work or travel.

Globalist Pandemic Health Tyranny Threatens Residents of Island Nations of Barbados, Grenada, St. Kitts & Nevis, Anguilla and Free Travel guaranteed by the United Nations Declaration of Human Rights¹

The International Natural and Common Law Tribunal for Public Health and Justice², a private Tribunal of Conscience, with representatives from nations on 4 continents, has engaged in a process of indictment, trial and judgment against various international actors for the foreseeable harms generated by the COVID-19 Declared Pandemic and the rushed-to-market gene-altering "vaccines."

On April 15, 2021, The Tribunal, in response to human emergency requests from the Island Nations, issued orders to **“CEASE & DESIST Emergency Injunction Immediately halting all ‘COVID VACCINATIONS’ [GENETIC BIOWARFARE] in your Jurisdiction as Genocide and Crimes against Humanity**

Pursuant to the Tribunal's Final Order of November 29, 2020 and its Universal Jurisdiction under Natural and Common Law, under Articles 6 and 7 of the International Criminal Court Statute banning Genocide and Crimes Against Humanity³, and under 18 USC 1091,

“You Are Hereby Ordered To CEASE & DESIST and Immediately Halt The Distribution And Use Among The Human Population In Your Jurisdiction Of Any And All “COVID VACCINATIONS” [GENETIC BIOWARFARE] As Constituting Genocide And Crimes Against Humanity In Your Jurisdiction.”

The Tribunal’s Orders to Cease and Desist all COVID Vaccinations as Genocide were served directly on the National Heads of Government of the Four Island Nations as follows:
