The International Natural and Common Law Tribunal for Public Health and Justice<sup>2</sup>, a private Tribunal of Conscience, with representatives from nations on 4 continents, has engaged in a process of indictment, trial and judgment against various international actors for the foreseeable harms generated by the COVID-19 Declared Pandemic and the rushed-to-market gene-altering "vaccines."

On April 26, 2021, The Tribunal, in response to human emergency requests from Antigua and Barbuda, issued orders to **“CEASE & DESIST Emergency Injunction Immediately halting all ‘COVID VACCINATIONS’ [GENETIC BIOWARFARE] and PCR tests in your Jurisdiction as Genocide and Crimes against Humanity**

Pursuant to the Tribunal's Final Order of November 29, 2020 and its Universal Jurisdiction under Natural and Common Law, under Articles 6 and 7 of the International Criminal Court Statute banning Genocide and Crimes Against Humanity<sup>3</sup>, and under 18 USC 1091,

**“You Are Hereby Ordered To CEASE & DESIST and Immediately Halt The Distribution And Use Among The Human Population In Your Jurisdiction Of Any And All “COVID VACCINATIONS” [GENETIC BIOWARFARE] As Constituting Genocide And Crimes Against Humanity In Your Jurisdiction.”**

The Tribunal’s Orders to Cease and Desist all COVID Vaccinations as Genocide were served directly on the National Head of Government of Antigua and Barbuda as follows:
