ORDER TO CEASE AND DESIST

- **UNLAWFUL USE OF PROPRIETARY COPYRIGHT & TRADEMARK NAME AND LOGO OF TRIBUNAL**
 - **UNLAWFUL ATTEMPT TO EXTORT CHARITABLE DONATIONS LAWFULLY RAISED FOR ENFORCEMENT OF TRIBUNAL’S JUDGMENTS AND CEASE & DESIST ORDERS**

1. This Cease and Desist Order is hereby served upon Charles Seven of the UK at <https://lawtribunal.net/>, a website owned and established by Charles Seven.

2. Charles Seven of the UK is knowingly using the website <https://lawtribunal.net/> in unlawful, continual, intentional, hostile, violation of the Proprietary Copyright and Trademark Name and Logo of the NATURAL AND COMMON LAW TRIBUNAL FOR PUBLIC HEALTH AND JUSTICE (“TRIBUNAL”) at www.peaceinspace.org.

3. Charles Seven of the UK is knowingly using the website <https://lawtribunal.net/> in unlawful, continual, intentional, hostile purposes of unlawful extortion for her own selfish purposes of charitable donations raised by the NATURAL AND COMMON LAW TRIBUNAL FOR PUBLIC HEALTH AND JUSTICE (“TRIBUNAL”) at www.peaceinspace.org for enforcement of the Tribunal’s Judgments and Cease and Desist Orders.

4. Charles Seven, a former Judge on the Tribunal duly discharged for cause, alleges in a <https://lawtribunal.net> document dated June 21, 2021 on that she is owed the Tribunal Charitable Donations raised for services rendered, whereas all Tribunal Judges, including Charles Seven, served knowing that service on the Tribunal was voluntary and without financial compensation. Several times while Charles Seven was a Judge, he requested that Charles Seven submit a documented request to him for charitable funds allocated to emergency survival needs including rent, and on each such time Charles Seven failed to submit such request for a rental survival request.

5. Charles Seven allegations in her <https://lawtribunal.net> document dated June 21, 2021 Continue her false allegations of prior public submissions, only this time with serious:

- Unlawful Use Of Proprietary Copyright & Trademark Name And Logo Of Tribunal
- Unlawful Attempt To Extort Charitable Donations Lawfully Raised For Enforcement Of Tribunal's Judgments And Cease & Desist Orders

This Tribunal takes very seriously: (1) Documented and Unlawful Use Of Proprietary Copyright & Trademark Name And Logo of the Tribunal, and (2) Documented and Unlawful Attempt To Extort Charitable Donations Lawfully Raised For Enforcement Of Tribunal's Judgments And Cease & Desist Orders. This Tribunal will take steps to enforce its Proprietary Copyright & Trademark Name And Logo and to enforce against any further Documented and Unlawful Attempt To Extort Charitable Donations Lawfully Raised For Enforcement Of Tribunal's Judgments And Cease & Desist Orders.
