Compliance Order - How the Convicted and Notified Defendants can come into compliance with the Tribunal's Judgments:

ENFORCEMENT OF JUDGMENT

1. Deliver a UK Parliament Throne Speech and Grant Royal Assent to UK Parliament Legislation to ban (a) Any and all allopathic Vaccinations including COVID vaccinations, and Any and all uses of Aspartame under any of its names for human consumption worldwide, (b) Any and all 5G and above installations and activations worldwide, (c) Genocidal Pandemic Social Control Methods like mandatory Lockdowns, Masking, quarantines, Detention Centers, Concentration Camps, etc., (d) Any and All intentional disinformation and misinformation by media and Social media concerning the Genocidal Technologies Pandemic as defined in the Indictment, (e) Any and All Financial abuse or fraud by Financial, Banking or Unjust Enrichment entities or individuals regarding the Genocidal Technologies Pandemic as defined in the Indictment, (f) Any and All abuse by Sentient and/or Strong or Other AI Artificial Intelligence around the Genocidal Technologies Pandemic as defined in the Indictment, (g) Any and All 2009-2020 and beyond Criminal Co-conspiracy around the Genocidal Technologies Pandemic by named and unnamed Defendants in the Indictment.

2. Deliver a UK Parliament Throne Speech and Grant Royal Assent to UK Parliament Legislation to (a) Claw back Unjust Enrichment from Pandemic profiteers such as and not limited to: Bill Gates, Jeff Bezos, GAVI the Vaccination Alliance, and Vaccination companies [See financial data in Indictment], and (b) Establish a South Africa style Truth & Reconciliation Commission to apply Restorative Justice to Pandemic Defendants [as opposed to Retributive Justice like death penalty - These terms are defined toward the end of the Indictment]

3. Deliver a UK Parliament Throne Speech and Grant Royal Assent to UK Parliament Legislation for Enforcement at the UK National Courts - Enforcement of the Tribunal's Judgments at UK National Courts, as the UK has ratified the International Criminal Code The 123 Nations ratifying the International Criminal Code are listed at: [All the States that have ratified the International Criminal Court Statute](https://exopolitics.blogs.com/international_criminal_co/2020/09/all-the-states-that-have-ratified-the-international-criminal-court-statute) https://exopolitics.blogs.com/international_criminal_co/2020/09/all-the-states-that-have-ratified-the-international-criminal-court-.html

4. Surrender all financial and real property personally owned by or in trust for these above named Defendants - not to include property owned by the Crown operating as the United Kingdom or a political subdivision thereof - which shall be seized and confiscated and paid into a public Trust established for the Pandemic Restorative Justice Process.

5. Deliver a UK Parliament Throne Speech and Grant Royal Assent to UK Parliament Legislation for Public Referendum in all affected communities shall be held as soon as feasible on the issue: What form of Self-Governance shall the communities, Peoples, and Nations, respectively, formerly known as the United Kingdom and the Commonwealth Nations adopt?

6. The above named Defendants shall Abdicate and be immediately, publicly, irrevocably disestablished as Sovereign Monarchs or holders of any public office of the United Kingdom, and

7. These above named Defendants shall serve incarceration sentences of Life Imprisonment without Parole.
