

AND UPON Judge Alfred Lambremont Webre opening and running a crowd funded Tribunal donation page for many months which had specifically featured Tribunal co-founder Judge Lady Seven's urgently requiring funds to transfer from a domestic violence refuge into safe secure accommodation but Judge Alfred Lambremont Webre *did not hand over the money* to Judge Lady Seven but instead unlawfully and unethically *kept the public's donated money for himself*

AND UPON the final Judgement and Order dated 14th June 2021 establishing that Judge Lady Seven co-founded the '**Natural and Common Law Tribunal for Public Health and Justice**' together with Chief Judge Alfred Lambremont Webre on 26th March 2020

AND UPON the final Judgement and Order dated 14th June 2021 establishing that Judge Lady Seven had co-founded the '**Natural and Common Law Tribunal for Public Health and Justice**' on 26th March 2020 together with Judge Alfred Lambremont Webre until he sold the Tribunal out to Cointelpro deepstate infiltrators resulting in Judge Lady Seven being unlawfully informed by way of email without due process, investigation and Tribunal inquiry that she was being unlawfully removed by way of defamation, malicious slander, libel along with multiple other honourable Tribunal Judges in April 2021 after :-

- a) She had worked tirelessly for over a year to get the Tribunal recognised and established internationally using her own money whilst in a domestic violence refuge without receiving a single penny without a shred of gratitude, appreciation or respect from fellow co-founder Alfred Lambremont Webre
- b) she shed blood, sweat and tears and moved mountains to get the Tribunal recognised in circles, organisations and networks, he and his deepstate executive team would not have thought of or had access to without her
- c) she regularly provided Judge Alfred Lambremont Webre with a constant stream of up to date evidence for the Tribunal indictments
- d) regularly provided relevant international reports for Tribunal hearings
- e) regularly researched applicable laws violated in regards to Covid-19 highlighted in videos
- f) had arranged and produced all the Tribunal press conferences
- g) had invited and arranged all expert guests who appeared on the press conferences

- h) had made links for the Tribunal with a multitude of other international organisations and networks
- i) reviewed and created legal documents used in videos
- j) regularly innovated new promotional ideas for the Tribunal
- k) regularly independently made videos promoting the Tribunal
- l) made videos interviewing Judges to promote the Tribunal called 7 questions until there was interference to stop her
- m) got the Tribunal plastered all over social media
- n) got the Tribunal all over radio internationally
- o) was the one who suggested for the Tribunal to have regular weekly or fortnightly enforcement meetings to keep up the momentum
- p) brought in many of the Tribunal Judges, who later became reluctant to attend because of the messy constant emailed abuse to Tribunal Judges
- q) regularly kept judges up to date and informed and motivated them to remain onboard
- r) regularly did write ups on social media groups and pages promoting the Tribunal which always went viral
- s) rallied and motivated countless other people to promote the Tribunal internationally
- t) created artwork for hashtags to promote the Tribunal
- u) regularly did live podcasts and radios shows internationally morning, noon and night to the point of exhaustion
- v) regularly organised scheduled appointments for Judge Alfred Lambremont Webre to speak together as the Tribunal co-founders on international platforms, panels and live talk radio shows to promote the Tribunal
- w) regularly organised scheduled appointments for Judge Alfred Lambremont Webre to speak alone on international platforms, podcasts, panels and live radio shows
- x) she got the Tribunal to younger audiences
- y) she got the Tribunal to eclectic alternative audiences

- z) she got the Tribunal to intellectual audiences
- aa) she got the Tribunal to creative audiences
- bb) she got the Tribunal into black and cultural audiences around the world
- cc) she got the Tribunal to musicians and celebrities around the world
- dd) she got the Tribunal to Law audiences
- ee) she got the Tribunal to activist audiences
- ff) she got the Tribunal to spiritual audiences
- gg) she got the Tribunal to indigenous people in remote places
- hh) she got the Tribunal to nursing audiences
- ii) she got the Tribunal to 5G expert circles and audiences
- jj) she got people from all over the world to donate to the Tribunal (and did not receive one penny)
- kk) she made videos Thanking the public for their help and donations
- ll) She spent every penny she had paying to get online services to promote the Tribunal because she was often obstructed

AND UPON Judge Alfred Lambremont Webre repeatedly being asked to hand over the public's crowd funded donations he had collected for Judge Lady Seven to pay for emergency accommodation and his ignoring all requests to return the monies intentionally knowing he was leaving Judge Lady Seven in dire dangerous emergency circumstances facing homelessness

AND UPON Judge Alfred Lambremont Webre depriving and keeping Judge Lady Seven's donations sent for her from the public and also keeping all secret illicit deals for her work for himself constituting theft, fraud and RICO crimes

IT IS ORDERED THAT:-

- 1) Judge Alfred Webre immediately provide a full financial account and statement by way of affidavit under penalty of perjury for all donations he received and collected on

behalf of Judge Lady Seven Monday **21st June 2021** in accordance with the previous Order dated 14th June 2021

- 2) Judge Alfred Lambremont Webre immediately provide a full account and statement byway of affidavit under penalty of perjury of all secret illicit monetary deals done for the '**Natural and Common Law Tribunal for Public Health and Justice** with his Cointelpro deepstate '**executive administration team**' behind Judge Lady Seven's back detailing all monies he has received by Monday **21st June 2021**
- 3) Judge Alfred Lambremont Webre immediately return *all* crowd funded donations sent by the public for Judge Lady Seven that he collected on her behalf by Monday **21st June 2021**
- 4) Judge Alfred Lambremont Webre immediately return all Judge Lady Seven's share of monies from all secret illicit monetary deals done behind Judge Lady Seven's back which if done, will have unlawfully resulted in Judge Alfred Lambremont Webre and his executive administration team receiving money for the Tribunal. Any and all monies received must be forwarded by Monday **21st June 2021**

AND IT IS ALSO ORDERED THAT:-

- 5) If Judge Alfred Lambremont Webre does not return all the public's donations collected on behalf of the Tribunal's co-founder Judge Lady Seven and also disclose and return any monies collected from secret illicit monetary deals by Monday 21st June 2021 an international RICO court action will be taken against Judge Alfred Lambremont Webre for theft and fraud of the Public's crowd funded donations and illicit trading byway of using the **Natural and Common Law Tribunal for Public Health and Justice** to arrange crimes under the **RICO Act** (Racketeering In Corrupt Organizations)
- 6) A set fixed reasonable amount of compensation for damages to be paid to Judge Lady Seven and other unlawfully mistreated and removed Tribunal Judges who unfairly suffered Defamation, Malicious Slander and Libel to be arranged and settled by **28th June 2021**

- 7) Judge Alfred Lambremont Webre provide a full detailed affidavit under the penalty of perjury including an apology and explanation for his actions as is set out in accordance within the previous Order of 14th June 2021 to be received by latest **28th June 2021**
