To the Police Association of Ontario, Canada and all regional Police Associations,

Recently the individual, Doug Ford, acting as the Premier of the Service Corporation of ONTARIO asked police officers across the province to once again break the law and violate their oath to safeguard the fundamental rights and freedoms of Canadian citizens and operate outside

their mandates, legal system, common law, international law and jurisdiction. I would kindly like to remind you of the code of conduct, specifically from the schedule in O. Reg. 268/10: GENERAL under Police Services Act, R.S.O. 1990, c. P.15, s2 (1) (c):

2 (1)(c) Neglect of Duty, in that he or she,

(vi) fails to report a matter that it is his or her duty to report,

(vii) fails to report anything that he or she knows concerning a criminal or other charge

You are needed and respectfully requested and demanded to investigate fully the following INFORMATION. This is a PLEA FROM WE THE PEOPLE to UPHOLD YOUR DUTIES AND OBLIGATIONS UNDER THE POLICE SERVICES ACT, CHARTER OF RIGHTS AND FREEDOMS, CONSTITUTION ACT AND BILL OF RIGHTS, INTERNATIONAL COVENANTS AND TREATIES, GENEVA CONVENTION AND THE NURENBERG CODE AND YOUR OATH - to arrest INDIVIDUALS ACTING AS PREMIERS, MAYORS & ACCOMPLICES, for criminal code violations including HOAX - Terrorism & CRIMES AGAINST HUMANITY.

Both of these files will show more than enough evidence for reasonable grounds for what is being requested.

Please also note that parents have filed statements of occurrence for **crimes against their children** and presented the binder of evidence in Halton Region (through Staff Sgt Crystal Kelly), St Catharines (through David Masotti and Chief MacCulloch) and Peel (through Detective Sergeant Valerie Graham #1290). Each of these statements resulted in **no investigations, no follow ups and no assistance to the parents and children**. A citizen's arrest of the mayors of Burlington, Oakville, Milton and St Catharines was performed under bill c26, CCC section 494(2). Again, no police assistance was offered and the children were left to suffer. A common law court was convened on March 20<sup>th</sup>, 2021 and mayor Bonnie Crombie was found guilty of crimes against humanity and abuse on the children: <https://www.youtube.com/watch?v=LoquHQeqyo8&t=2009s>. This verdict was sent to the International Tribunal.
