Pursuant to the Tribunal's Final Order of November 29, 2020 and its Universal Jurisdiction under Natural and Common Law, under Articles 6 & 7 of the International Criminal Court Statute banning Genocide and Crimes Against Humanity⁷, and under 18 USC 1091 - Genocide,

You Are Hereby Ordered To CEASE & DESIST and Immediately Halt all NEW & EXISTING "MICROWAVE FACTORY" AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE -related Cell Towers and Any and All "MICROWAVE FACTORY" AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE Installations [“MICROWAVE FACTORY" AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE] in your Jurisdiction as War Crimes, Genocide, Crimes against Humanity, and Aggressive War.

During the meeting the prime ministers did discuss the implementation of **"MICROWAVE FACTORY" AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE** and entered into a new in-depth collaboration on 5G. The importance of **"MICROWAVE FACTORY" AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE** was acknowledged in the Nordic-Baltic ministerial declaration Digital North that was adopted in 2017. As the development of fifth generation wireless systems (“**MICROWAVE FACTORY**” AKA 4G, “**MICROWAVE FACTORY**” AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE , 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE) breaks through, the Nordic countries will be at the forefront of that development to become world leaders in using “**MICROWAVE FACTORY**” AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE technology for the development and digitalisation of all sectors of society. We want to create a common Nordic “**MICROWAVE FACTORY**” AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE space. To achieve this goal, we will cooperate closely to set up a common action plan for early adoption of “**MICROWAVE FACTORY**” AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE technology across the Nordic region. The action plan will:

- Encourage the development of new testing facilities, including test beds;

The development of “MICROWAVE FACTORY” AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE will be monitored and followed up by the Nordic Council of Ministers, facilitating implementation in cooperation with the Nordic governments, national digital authorities, and stakeholders from the ICT and telecom industries. We ask the Nordic digitalisation ministers to take the lead in following up this declaration with the aim of ensuring that the Nordic region becomes the first and best interconnected “MICROWAVE FACTORY” AKA 4G, 5G, 6G & ABOVE ELECTROMAGNETIC ANTI-PERSONNEL WARFARE region in the world.

Summary: We know that there is a massive literature, providing a high level of scientific certainty, for each of eight pathophysiological effects caused by non-thermal microwave frequency EMF exposures. This is shown in from 12 to 35 reviews on each specific effect, with each review listed in Chapter 1, providing a substantial body of evidence on the existence of each effect. Such EMFs:

1. Attack our nervous systems including our brains leading to widespread neurological/neuropsychiatric effects and possibly many other effects. This nervous system attack is of great concern.
2. Attack our endocrine (that is hormonal) systems. In this context, the main things that make us functionally different from single celled creatures are our nervous system and our endocrine systems –even a simple Planaria worm needs both of these. Thus, the consequences of the disruption of these two regulatory systems is immense, such that it is a travesty to ignore these findings.
3. Produce oxidative stress and free radical damage, which have central roles in essentially all chronic diseases.
4. Attack the DNA of our cells, producing single strand and double strand breaks in cellular DNA and oxidized bases in our cellular DNA. These in turn produce cancer and also mutations in germ line cells which produce mutations in future generations.
5. Produce elevated levels of apoptosis (programmed cell death), events especially important in causing both neurodegenerative diseases and infertility.
6. Lower male and female fertility, lower sex hormones, lower libido and increased levels of spontaneous abortion and, as already stated, attack the DNA in sperm cells.
7. Produce excessive intracellular calcium $[Ca^{2+}]_i$ and excessive calcium signaling.
8. Attack the cells of our bodies to cause cancer. Such attacks are thought to act via 15 different mechanisms during cancer causation. There is also a substantial literature showing themes also cause other effects including life threatening cardiac effects (Chapter 3). In addition, substantial evidence suggests EMF causation of very early onset dementias, including Alzheimer's, digital and other types of dementias (Chapter 3); and there is evidence that EMF exposures in utero and shortly after birth can cause ADHD and autism (Chapter 5)

Elaine Unger of Greendale with Wisconsin For Safe Technology said, "There are zero studies proving 5G is safe. Zero. This bill strips us of our rights to protect our health, our privacy and our property. It also strips the rights of local government to protect us."

In Vienna, Austria, for instance, where 5G was reportedly unveiled "seemingly overnight," local residents are experiencing nosebleeds, headaches, eye pains, chest pains, nausea, vomiting, fatigue, dizziness, tinnitus, flu-like symptoms, and cardiac pain. There are also reports of people suffering from tightness and pressure in and around their heads, as well as experiencing feelings of "short, stabbing pains around the body" and a "buzzing" in their internal organs.

Both young and old are reportedly experiencing this 5G-induced trauma, though children seem to be most affected by 5G wireless radiation, which is emitted in the form of high-frequency millimeter waves (MMWs).

None of this is surprising, seeing as how 5G MMWs are roughly the same as those used in crowd control weapon systems, also known as Active Denial Systems, the purpose of which is to produce “an intolerable heating sensation that causes them to flee.” Such “heating sensations” have also been reported in conjunction with exposure to 5G.

“People’s first reaction to the idea that 5G may be an existential threat to all life on Earth is usually disbelief and/or cognitive dissonance,” a whistleblower from the United Nations (U.N.) is quoted as saying.

“Once they examine the facts, however, their second reaction is often terror. We need to transcend this in order to see 5G as an opportunity to empower ourselves, take responsibility and take action.”
