Introduction

Smartphone pings, video reveal at least 4.8 million fraudulent votes

Catherine Engelbrecht and Gregg Phillips have been engaged in the battle for election integrity for more than a decade, and the day after the contested November 2020 vote, they made a pact.

"Catherine looked at me and said, 'What are we going to do?'" Phillips recounted in an in-depth video interview with Turning Point USA founder Charlie Kirk.

"I said, Let's go," Phillips recalled. "She said, Let's go all in."

They eventually hired a dozen people who have put in 16-hour days for 15 months, combing tediously through cellphone geolocation data, surveillance videos and documents to see if the evidence supports their hypothesis.

Their hypothesis is that amid the many "dirty," out-of-date voter rolls and the unprecedented distribution of mail-in ballots, a highly coordinated operation in the key battleground states collected ballots and paid "mules" to literally stuff them in the unattended drop boxes that became a center of controversy.

Phillips, the founder of a health-care-data company, began lending his tech savvy to Engelbrecht's non-profit True the Vote in 2013 to analyze voter records across the nation, helping officials remove duplicates and registrations of non-residents, non-citizens and deceased voters.

They say they have the hard evidence to back their finding that there were 4.8 million fraudulent votes in the states they targeted – including Arizona, Wisconsin, Michigan, Pennsylvania and Georgia – but they've been shunned by authorities, and media won't touch it.

Much of the evidence of criminal behavior is indisputable. In Georgia, for example, it's illegal for any person to place more than one ballot in a drop box unless he or she has registered as an "assistant." In Gwinnett County, where there is video footage of people with latex gloves stuffing multiple ballots in a drop box then recording the deed with a photograph, there were no "assistors" registered for the 2020 election.

Engelbrecht and Phillips eventually took their two petabytes of data (the next highest measurement for data storage after terabytes, equalling 1,024 terabytes or 1 million gigabytes) to filmmaker Dinesh D'Souza, whose feature "2000 Mules" is in post-production.

After the movie comes out and the inevitable attacks come, Phillips said the investigative team will "pull the rip cord" and release all of the data.

Engelbrecht said they want to be totally transparent" and "give it all to the American people."

"Now you can see what nobody is showing you to this point," she said.

Phillips noted there's a lot of fear surrounding the raising of any questions about the 2020 election.

"Everybody's afraid right now. They're afraid of getting canceled," he said, but "on the other side of fear is freedom."

"All you've got to do is step up," he said. "Let's go."

'Prayerful consideration'

Kirk recalled that Engelbrecht was targeted by the Obama administration after her group exposed the IRS discrimination against conservative non-profits in their application for tax-exempt status. The IRS, Justice Department, FBI, ATF and OSHA launched a total of 23 audits, investigations and inquiries against True the Vote.

She said that experience "stealed me for this moment."

Ten years ago, she said, "I really had to do some prayerful consideration," asking herself if "that really" was "what True the Vote was about."

She decided to "fight it out" in court and sue the IRS, emerging victorious more than six years later.

"I think this is what True the Vote's been put here to do," Engelbrecht said, "to take us into the other side of the mountain." SOURCE: <https://www.wnd.com/2022/04/18-month-data-driven-probe-concludes-2020-election-stolen/>

2000 Mules - A film review

2000 Mules, if you're not already aware, is a hard-hitting documentary by Dinesh D'Souza about the 2020 presidential election fraud.

The film centers around data collected by True The Vote, specifically regarding the mail-in ballot fiasco which was heavily financed by none other than Mark Zuckerberg who apparently pumped more money into defeating Trump than has ever been spent by a private individual. In it we discover how the drop-boxes were illegally "stuffed" by thousands of "mules" in a few key swing states. The film is described as...

... a documentary film created by Dinesh D'Souza, exposes widespread, coordinated voter fraud in the 2020 election, sufficient to change the overall outcome. Drawing on research provided by

the election integrity group True the Vote, "2000 Mules" offers two types of evidence: geotracking and video. The geotracking evidence, based on a database of 10 trillion cell phone pings, exposes an elaborate network of paid professional operatives called mules delivering fraudulent and illegal votes to mail-in dropboxes in the five key states where the election was decided. Video evidence, obtained from official surveillance cameras installed by the states themselves, confirms the geotracking evidence. The movie concludes by exploring numerous ways to prevent the fraud from happening again.

2000 Mules, like most professional productions, was a just a wee bit too dramatized for my taste. The evidence was collected and processed in an exceedingly methodical and scientific manner that consumed an enormous amount of time and the film doesn't really do the scientific method justice, nor does it mention that the evidence cost True The Vote around one million dollars, not including the cost of producing the documentary. The back-story of the investigation is covered by Charlie Kirk in an interview with two of the True The Vote team members, Catherine Engelbrecht and Greg Phillips.

While a massive amount of data of around one petabyte (1,048,576 gigabytes) was acquired through information requests in order to make the documentary, that data is representative of only a fraction of the total data available regarding the mail-in ballot fraud, and the mail-in ballot fraud itself is only a fraction of the total scope of the illegal activity which took place and which included wide-spread computer fraud where, in one instance, votes were flipped in real time as we witnessed live on CNN.

2000 Mules is a hell of a film that will surely raise a fuss, but it only confirms what many researchers already knew. Furthermore it represents only one small piece in a much larger puzzle. The film makers largely stuck only to what they could prove however and they did a fine job at it.

The film makers tell us that the United States has never in its history witnessed election fraud on the scale we saw during the 2020 presidential election and i find that quite easy to believe given the overwhelming evidence that has surfaced thus far. Trump not only won in terms of the number of votes he received, but the margin may have been a landslide never surpassed in the history of U.S. presidential election.

In my state, a blue state, i do a fair amount of traveling and the ratio of pro-Trump verses pro-Biden campaign signs leading up to the election was roughly 10:1. Granted this is not representative of the sentiments of the nation, but i also talked to several long-haul truck drivers and they all told me that they saw the same thing across the country. The evidence of how people intended to vote was further backed by the fact that there were often fewer than 25 people attending Biden campaign rallies while hundreds, thousands and tens of thousands packed the venues for Trump.

The democrats however weren't having it; they went to absolutely extraordinary lengths to ensure that a demented, babbling, war-mongering retard unable to navigate a stairway would be installed in the White House instead, not that "The Donald" deserves anywhere near the praise he has been adorned with by his uninformed followers.

The film is likely to paint Trump as something of a martyr in the eyes of those who have never bothered to actually study the man's background and this is decidedly unfortunate. While Trump may be less stinky than a Biden or an Obama or, dare i say, a Clinton, he is nevertheless an Israeli-loving, corrupt, neanderthal-minded jackass who is most proud of fast-tracking the death and destruction brought forth by the COVID-19 "vaccines" for those uninformed enough to have

subjected themselves to the poison. This should of course should come as no surprise given that Big Pharma was quite kind to Trump, Pfizer alone donating \$1 million to help finance his inauguration.

This is not to say that Trump is all bad. He did indeed accomplish some good things, among them setting the stage for pulling U.S. troops out of Afghanistan, which Biden botched terribly, pulling funding from the WHO, attacking racist inciting Critical Race Theory and attempting to secure the border which the Biden admin immediately reversed, however the most crucial items were left untouched, such as forcing AIPAC to register as a foreign agent, eliminating the private central banks and closing down overseas military bases.

What i find particularly ironic about the ludicrous, multi-year effort to tie Trump to Russia by the screeching, brain-dead radical left is the fact that the connections are obvious. Trump has been in bed with the Russian-Jewish mafia at least as far back as the construction of Trump Tower, some of the early inhabitants of which were these very criminals. The problem, i suspect, is that the radical left communists couldn't possibly explore that rabbit hole because it would circle right back and bite them in the ass. Jake Morphonios of Blackstone Intelligence details these collisions in his series, Trump's Ties to Russia.

It is a sad state in which we exist and 2000 Mules presents formidable and transparent proof of one aspect of this, however as long as people continue to succumb to group-think and vote based on what they see on the boob-tube and what their peers say, we will never make any real progress.

I think that Ron Paul and, to a lesser extent, Tulsi Gabbard [Editorial Note: Tulsi Gabbard is a favored young leader of the World Economic Forum], may have been the last hopes of accomplishing anything meaningful in American politics and foreign policy and i don't see us recovering from our failure to elect them given how exceedingly fast the train to doom is speeding these days. The breaks are off and it's hard to imagine how it can be stopped when corrupt, criminal, psychopathic governments around the world are happily sacrificing the sovereignty of their nation states to globalist organizations such as the United Nations, Bill Gates' World Health Organization and Klaus Schwab's World Economic Forum.

As long as uneducated people continue to vote for the "lessor evil", they ensure that's all they'll ever have.

FBI intelligence warning that Jan. 6 protesters might violently storm the Capitol, target lawmakers and blockade Democrats in tunnels was never sent to frontline police commanders and officers, but was quietly emailed the night before to a top aide to Senate Majority Leader Chuck Schumer, according to documents that raise new concern that politics trumped security preparedness in the fateful hours before the riot.

The information explicitly warned that demonstrators had detailed maps of the tunnel systems around the Capitol frequented by lawmakers and their staffs and they were plotting to create a “perimeter” for potential violence and to find “Democratic members early to block them from entering the Capitol.” One point of entry the rioters were targeting was the Library of Congress, he warned.

“Similar to the intelligence already in IICD’s possession prior to January 5, the FBI SIR and the warning regarding the tunnel system were not elevated to USCP leadership,” the report noted as one of many intelligence and security failures of the department’s leadership.

January 6 Hearings

First Hearing on Investigation of January 6 Attack on the U.S. Capitol

The House Select Committee to Investigate the January 6th Attack on the United States Capitol held the first of a series of hearings. Committee Chair Bennie Thompson (D-MS) said, “Donald Trump was at the center of this conspiracy,” and that the former president “spurred a mob of domestic enemies of the Constitution to march down to the Capitol and subvert American democracy.” Addressing her Republican colleagues directly, Committee Vice Chair Liz Cheney (R-WY) said that those who “are defending the indefensible, there will come a day when Donald Trump is gone, but your dishonor will remain.” U.S. Capitol Police Officer Caroline Edwards, who was knocked unconscious during the initial breach, and filmmaker Nick Quested, who was filming the Proud Boys and the rally, shared their stories from the attack. The committee showed a video of the attack with scenes outside and inside the Capitol, much of which came from police cameras, and video testimony gathered during months of investigation.

Second Hearing on Investigation of January 6 Attack on the U.S. Capitol

The House Select Committee to Investigate the January 6th Attack on the United States Capitol held the second of a series of hearings. Committee Chair Bennie Thompson (D-MS) said that former President Donald Trump “betrayed the trust of the American people” and “ignored the will of the voters,” as he tried to remain in office even after being told he lost the 2020 election. While testifying on allegations of voter fraud in Pennsylvania, specifically those levied by President Trump’s former attorney Rudy Giuliani that thousands of dead people in the state cast their vote in the election, former Philadelphia City Commissioner Al Schmidt said, “not only was there not evidence of 8,000 dead voters voting in Pennsylvania, there wasn’t evidence of eight.” During the hearing, the committee showed never-before-seen video testimony of President Trump’s campaign manager, William Stepien, and former Attorney General William Barr refuting the former president’s claims of voter fraud.
