Documents/Evidence & Relevance

Personal Evidence:

- Elderly (like myself) are not seeking medical advice because they (I) are afraid of being forced onto a ventilator which will likely cause death
- Other people are not going for cancer screening and treatment, surgeries, and seeking help for heart attack symptoms, because these conditions were claimed to be non-essential and are dying as a result. Cancer is expected to go up 40% as a result
- Elderly are not allowed to see family and are dying alone in care facilities
- Masks eliminate facial expression and mute the sound of voices so those of us (like me) who are hard of hearing do not understand instructions and cannot lip read. **Communication is impossible and then we are seen as uncooperative and rebellious trouble makers.**
- In April 2020, the hospitals were empty despite claims of overload
- Masks are now legally mandated, and people who are unable to wear masks, cannot go into any stores and so cannot get food and necessities
- As of November 30, 2020 (in Red Deer, Alberta) you cannot shop anywhere without a mask: We cannot be in any public place without a mask or we receive a \$50.00 fine. This includes public transportation and out-of-doors if we cannot maintain at least 6 feet social

distance. - h. Increased public harassment from mask wearers – my experience which limits social community
- i. Increased liquor consumption and family decay – my son’s partner works for a delivery service here in Red Deer, Alberta. She has noticed a huge increase of alcohol consumption and has seen evidence of family decay.
- j. Many businesses do not accept medical exemptions (which violate privacy rights) and the doctors in Red Deer, Alberta are no longer giving mask exceptions.
