The principal qualification for Judges is that they are persons of Conscience, in the case of the Genocidal Technologies Pandemic, that in their Conscience they are moved to stop this genocidal false flag using the instruments of Natural, Common Law, Treaty Law. Our Judges include activists, authors, common law Judges, podcasters, journalists, entrepreneurs, nurses, lawyers, physicians. The basic quality that is common to all of them is their Conscience and dedication to the Tribunal process - as if they were on Jury Duty. It does not matter what race, gender, nationality, political orientation, etc. they are. The language of the Tribunal is English as we do not have interpreters, though.

Each individual upon becoming a Tribunal Judge makes a judicial affirmation as follows:

"I affirm as a Tribunal Judge of the Natural and Common Law Tribunal for Public Health and Justice that to the best of my ability I will render Justice using Natural Law, Common Law, International Treaty Law, and Social Law. I acknowledge that the Tribunal is organized as a Committee of the Whole, on a consensus basis under Natural and Common Law principles. I acknowledge my duties as Tribunal Judge and I will faithfully participate in periodic Judges meetings, judicial proceedings, Tribunal Indictments, Tribunal trials, Tribunal Enforcement proceedings, and review indictments, judgments, and cease and desist orders, Tribunal criminal sentencing, and other Judicial matters as determined by the Tribunal. I will treat fellow Tribunal Judges with fundamental Judicial respect and honour, and will not engage in ad hominem attacks against fellow or former Tribunal Judges, or in factionalism among Tribunal Judges. I will respect the confidentiality of Tribunal proceedings and not engage in *ex parte* or secret communications with active or former Tribunal Judges about confidential Tribunal proceedings or business. I further affirm that I am not an agent of any governmental, corporate or other interest, private, public or otherwise which stands in opposition to the activities and aims of the Tribunal in any way and; that I will render good counsel and/or a true verdict based on the facts and law produced, without regard to personal prejudices, benefit and/or political beliefs."

6. As the Tribunal discusses in the interview with Tribunal Of Counsel Ole Dammegard below, the Tribunal is seeking 10 -15 new Judges to join it:
