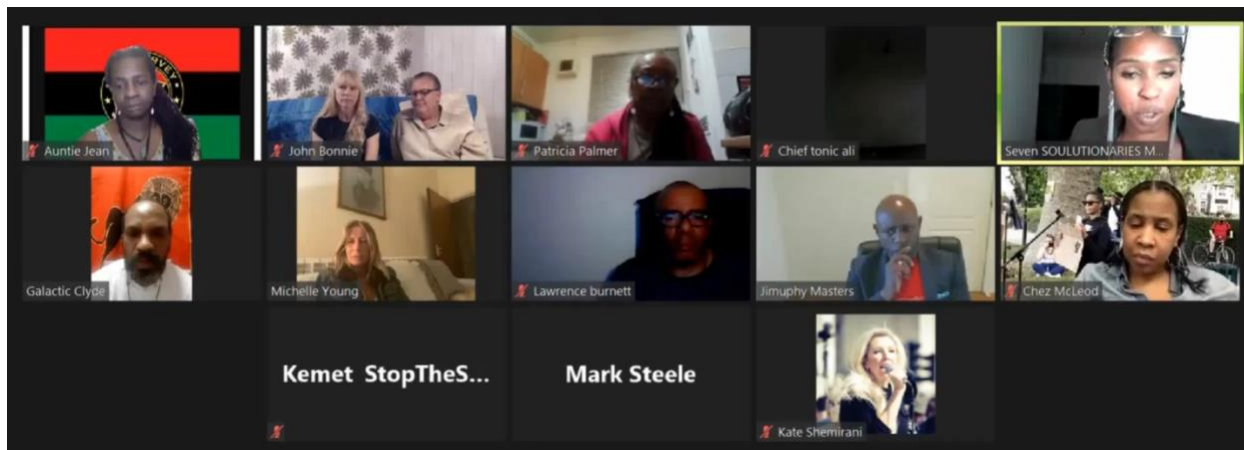

Tribunals of Conscience and *Crimes Against Humanity*

Over the past century and more, various private Tribunals of Conscience have focused the moral judgment of humanity in situations where official bodies have either failed to hold violators of

human rights to account or have been themselves the perpetrators of horrific acts that shock the conscience.

These nongovernmental, private expressive associations must be distinguished from international legal tribunals, such as the *Nuremberg Tribunals* and the *International Court of Justice*, which are examples of multinational courts established by governments under international law to try cases of making war and of war crimes.

International Criminal Tribunals

Discussing the impact of International Criminal Tribunals, a recent paper from the Netherlands noted,

“The idea that a ruler’s power cannot be absolute, that there must be standards beyond the ruler to protect his citizens, has become the foundation stone of international human rights law. But the idea of international criminal law, and international criminal tribunals, goes a step further. In the extreme case where the ruler commits or condones crimes against his people, it takes not only the formulation of norms, but also the administration of punitive justice out of his hands and up to the international level, even to the point where he himself can be tried on criminal charges.
...

Yet the symbolic power of international criminal tribunals may be far greater than their legal authority and capacity would suggest. In the cases of Georgia and Kenya, the threat of an ICC investigation appears to be spurring national investigations. Above all, in the former Yugoslavia and in the situations the ICC is currently investigating, the existence of the investigations has given local civil society actors room to discuss “difficult subjects” related to the recent past, such as the occurrence of massacres, the use of mass rape as a political instrument, the use of child-soldiers, and the issue of accountability in whatever shape.” [1]

Crimes Against Humanity

International Law is ambiguous with regard to Crimes Against Humanity (CAHs).

“Unlike genocide and war crimes, which have been widely recognized and prohibited in international criminal law since the establishment of the Nuremberg principles, there has never been a comprehensive convention on crimes against humanity, even though such crimes are continuously perpetrated worldwide in numerous conflicts and crises. There are eleven international texts defining crimes against humanity, but they all differ slightly as to their definition of that crime and its legal elements.” [2]

While the phrase “Crimes Against Humanity” (Class C Charges) was used in the post-World War II imposition of “victors justice” against CAH perpetrators on the losing side, “the charge of crimes against peace was a prerequisite to prosecution—only those individuals whose crimes included crimes against peace could be prosecuted by the Tribunal. In the event, no [independent] Class C charges were heard in Tokyo...” [3]

The failure of governments to respond to public concerns regarding CAH necessitates and justifies private persons constituting themselves into private associations for the purpose of condemning violations of basic humane standards.

Before the earliest Tribunals of Conscience there were several important international campaigns which contained elements later developed by the Tribunals. These include campaigns against slavery which started even before the beginning of the 19th Century. Often led by concerns of conscience, by religious libertarians such as the Quakers, the anti-slavery movement included a major element of the Tribunals: the public condemnation of acts seen as immoral. [4]

Similarly, private commissions of investigation were established to oppose the horrific abuses in the Congo during the early 19th Century when that territory was a personal fiefdom of the King of the Belgians. Slavery enforced by brutalities, including dismemberment, was widely condemned and various private campaigns, often led by clergy, investigated and condemned the violations of humanitarian standards. It was one of those campaigns where the phrase “Crimes Against Humanity” was first used. [5] Later the phrase was used in reference to the genocide against Armenians by the Ottoman Empire. [6]

Tribunals of Conscience

Various nongovernmental organizations (NGOs) have sought to define “Tribunals of Conscience”.

The National Lawyers Guild, for example, has posited the following:

“A Tribunal of Conscience is a People’s Tribunal. Such tribunals date back more than six decades to the era of the Russell Tribunal on US war crimes in Viet Nam and the Universal Declaration of the Rights of People (Algiers, 1976). They provide an alternative forum for those who find no recourse in the formal institutions of the state or the international community. They are the place where the people judge the crimes of the state, not where the state judges the people.” [7]

Perhaps the earliest self-denoted Tribunal of Conscience was that convoked by B. Russell and J-P. Sartre regarding the War in Vietnam, in 1966. After two public sessions in Europe the Tribunal published a strong condemnation of United States’ actions in Vietnam in 1967.

Russel quoted Robert H. Jackson, the Chief Nuremberg Prosecutor, in justification of the establishment of the Tribunal:

“If certain acts and violations of treaties are crimes, they are crimes whether the United States does them or whether Germany does them. We are not prepared to lay down a rule of criminal conduct against others which we would not be willing to have invoked against us.” — Justice Robert H. Jackson [8]

The Russel/Sartre Tribunal encouraged subsequent private efforts:

“Additional tribunals have been conducted in the following decades on the same model, using the denomination *Russell Tribunal*. E.g., The Russell Tribunal on Latin America focused on human rights violations in the military dictatorships of Argentina and Brazil (Rome, 1973), on Chile’s military coup d’état (Rome, 1974–76), on the situation of Human Rights in Germany (1978), on the Threat of Indigenous Peoples of America (1982), on Human Rights in Psychiatry (Berlin, 2001), on Iraq (Brussels, 2004), and on Palestine (Barcelona, 2009–12).” [9]

These efforts have also continued beyond the Russel/Sartre model. The “Permanent Peoples’ Tribunal was established at the behest of a member of the Senate of Italy in Bologna in the late 1970s. It has held 46 sessions regarding separate Crimes Against Humanity over the ensuing decades. [10] These sessions have reviewed situations involving CAHs primarily against peoples who are not recognized as “nations”, such as the population of Western Sahara or the Kurds, who live in several Middle Eastern nations.

Recent Developments

Other Tribunals of Conscience have included the 2009 Agent Orange Tribunal of the International Democratic Lawyers Association [11]; the 2020 Belmarsh Tribunal regarding the persecution of Julian Assange [12]; and the 2019 China Tribunal which states:

“The China Tribunal is an independent people’s tribunal established to inquire into forced organ harvesting from, amongst others, prisoners of conscience in China and to investigate what criminal offences, if any, have been committed by state or state-approved bodies, organisations or individuals in China that may have engaged in forced organ harvesting. “ [13]

During the 2020-2021 period of the “Declared Pandemic” the Natural and Common Law Tribunal for Public Health and Justice was established to hold the perpetrators of what the Tribunal found to be the “Genocidal Technologies Pandemic” accountable. It entered a formal judgment against various state-actors, politicians, businesses and NGOs for their various roles in triggering the false-flag “pandemic” and rushing “unavoidably unsafe” vaccines, including novel class of “gene altering” injections into production and deployment. Humanity Benefits from Tribunals of Conscience

“What”, the skeptic may ask, “is the value of private Tribunals of Conscience to humanity?”

We live in a world where the promise of global peace and prosperity has become a distortion used to empower globalist elites with their demonstrated eugenocidal agenda (most recently, through the Declared COVID Pandemic), where relations among nation-states resemble the brutal behavior of thugs — a true Hobbesian international order. The new religion of this world is Statism, the worship of the institutions of the States, including their judicial institutions and administrative indiscretions.

As the lack of intellectual viability of Statism in its various racial, religious, national, international, bureaucratic, imperialist and other forms becomes increasingly exposed and

become, perhaps, increasingly irrelevant in an economically globalized, blockchain-enabled, post-singularity world, an alternative to state-sponsored “justice” is needed.

The juridical subjects of International Law, “International Actors,” include nation-states (even micro-states like the Vatican), a certain few private associations (like the Red Cross or Sovereign Knights of Malta), and international agencies like the UN along with its associated institutions (such as certain privileged NGOs and “specialized agencies” — WHO and FAO, for example). Not included in this list are actual private persons, natural or cultural Nations, even juridical persons such as private associations and registered corporations.

The humans and human organizations with which we usually interact are missing from the globalist structure of international relations.

We individuals do not exist in the currently dominant Statist view of international law.

In the eyes of Globalist International Actors, we real people and our private associations are little more than disregarded entities. This state of affairs is entirely unsatisfactory to humane individuals.

Consider the long march of human history and how treating individual humans as objects led us to endless millennia of Statist imperial warfare, culminating the 20th Century’s killing fields and nuclear incinerations.

Consider the historic role of Statism in the imposition of what libertarian philosopher and lawyer Lysander Spooner saw as the Great Monopolies: the horror of slavery, vicious state churches, the legal “incapacities of women” and the King’s trade monopolies – all Statist institutions which have repeatedly perpetrated Crimes Against Humanity.

How can humanity trust the very Statist institutions which have so violated humane standards, by committing Crimes Against Humanity to exact meaningful justice for their own misdeeds, no matter how egregious?

Even as the vicious old concepts, chattel slavery, religious and racial bigotry, institutionalized inequality of women and various others, have become anathema to civilized people, the very concept a “sovereign” State, not subject to the same rule of law that applies to private persons, must also be rejected. States and their political elites must be subject to true Justice or there is no Justice.

Clearly, that justice will not come from the very source of the criminality. Private persons of conscience must take the lead to expose and publicly condemn Crimes Against Humanity. This is the role, which is of inestimable value to humanity, of Private Tribunals of Conscience.

5. Tribunal's Final Judgment of Nov. 29, 2020 – The Tribunal's Final Judgment of November 29, 2020 stops and enjoins the Genocidal Technologies Pandemic with immediate force and effect. The Final Judgment states:¹⁶

Tribunal Judges Affirmation - Tribunal Judges made this affirmation at the onset of the Trial or their Presentation segment:

"I affirm as a Tribunal Judge of the Natural and Common Law Tribunal for Public Health and Justice that to the best of my ability I will render Justice using Natural Law, Common Law, International Criminal Code, and Social Law."

Summation of Judgment, Verdict, and Sentences: With approximately 8 hours of Trial Testimony and deliberation, and an extensive Evidentiary Docket, the Tribunal Judges found allegations of the Indictment to be proven beyond a reasonable doubt and the Tribunal Judges approved the Emergency Injunctions and Writs of Mandamus as set out in the Indictment and Amendments, and handed out Incarceration sentences to Named Defendants in the Indictment, by Majority Aye vote, with 1 Abstention and 1 Nay vote.

the Tribunal hereby Orders:

2. **Emergency Writs of Mandamus** to (a) Claw back Unjust Enrichment from Pandemic profiteers such as and not limited to: Bill Gates, Jeff Bezos, and Vaccination companies [See financial data in Indictment], and (b) Establish a South Africa style Truth & Reconciliation Commission to apply Restorative Justice to Pandemic Defendants [as opposed to Retributive Justice like death penalty - These terms are defined toward the end of the Indictment]
3. **Development of 5G in the Nordic region**

Prime minister Stefan Löfven did invite prime minister colleagues Erna Solberg from Norway, Lars Løkke Rasmussen from Denmark, Juha Sipilä from Finland and Katrín Jakobsdóttir from Iceland to an annual informal Prime Minister meeting. Sweden is chairing Nordic co-operation this year and Prime Minister Stefan Löfven will host the meeting, which was held on 22–23 May in Örnsköldsvik in Sweden.

During the meeting the prime ministers did discuss the implementation of 5G and entered into a new in-depth collaboration on 5G. Their letter of intent clearly reveals their intentions regarding 5G and how

The Swedish prime minister Stefan Löfven stated that *“the Nordic region is one of the world's most innovative regions. The development of 5G is on the rise and the Nordic region must be at the forefront of that development. It creates jobs and prosperity in our countries”*.

In the letter of intent one can read the following:

The Nordic region is one of the most innovative and digitalised regions in the world. With our mature digital infrastructure, high level of digital skills and ambitious national strategies for digital transformation in the public and private sectors, we have the potential to take a leading role in the next leap for wireless communications. The

importance of 5G was acknowledged in the Nordic-Baltic ministerial declaration Digital North that was adopted in 2017.

As the development of fifth generation wireless systems (5G) breaks through, the Nordic countries will be at the forefront of that development to become world leaders in using 5G technology for the development and digitalisation of all sectors of society.

The deployment of 5G will require substantial investments as well as the appropriate regulatory framework. At political level, we commit to creating the conditions in the public sector for digitalisation and 5G to flourish. As Nordic prime ministers, we have agreed to the common vision of being the first and most integrated 5G region in the world. We want to create a common Nordic 5G space.

To achieve this goal, we will cooperate closely to set up a common action plan for early adoption of 5G technology across the Nordic region.

The action plan will:

- Encourage the development of new testing facilities, including test beds;
- Ensure the technical coordination of 5G frequency bands within the region;
- Remove obstacles to expansion of the 5G network, in particular deployment of base stations and antennas; and
- Encourage and monitor the development of 5G, specifically for certain sectors:
 - o Transport
 - Sustainable and climate-efficient transport solutions
 - Transport systems and connected vehicles
 - Remote-controlled airborne services ('drones')
 - o Mission critical communications
 - Emergency services
 - Law enforcement
 - o Advanced automation in the manufacturing industry
 - Augmented reality for employees
 - Interconnected factories

- Robust and low latency communications, e.g. for robot control of Energy, environment, agriculture and aquaculture
- Energy saving measures, smart grids, power management
- Increased yield in food production
- Detailed monitoring.

The development of 5G will be monitored and followed up by the Nordic Council of Ministers, facilitating implementation in cooperation with the Nordic governments, national digital authorities, and stakeholders from the ICT and telecom industries.

We ask the Nordic digitalisation ministers to take the lead in following up this declaration with the aim of ensuring that the Nordic region becomes the first and best interconnected 5G region in the world.

4. Criminal Intent or Scierter - Amendment to Indictment Tribunal Emergency Injunctions, Emergency Writs of Mandamus and Enforcement at the National Courts and other Venues

Because of a factual finding of Scierter or Criminal Intent, "a mental state in which one has knowledge that one's action, statement, etc., is wrong, deceptive, or illegal: often used as a standard of guilt", the following Criminal Sentences under the International Criminal Court Statute are Imposed by the Tribunal upon Named and Unnamed Defendants

7. 8. President of the Institute for Health Research, www.InHeRe.org, and Judge Michael Zazzio, a distinguished editor of medical journals in Sweden and long time medical practitioner are “deep state operatives” that infiltrated the Tribunal with a view to usurping Charles Seven’s judicial Role on the Tribunal. Unfounded allegations and assertions of a paranoid and wide-spread conspiratorial character are consistent with Charles Seven’s self-identified assertions, allegations, beliefs and statements that she is the subject of a lethal conspiracy, the unwitting and unwilling recipient of multiple high tech, invasive and dangerous devices in her body (e.g., implants in her eyes), that she is being consistently monitored, controlled and tortured by parties unknown for research and for sport.

According to some experts, her assertions that a major apartment block fire and other loss of life are aimed at her is consistent with allegations of mis-doing and guilt on the part of targets although these serious and potentially criminal accusations and allegations lack a shred of documentary evidence.

“Deep State” is a conspiratorial term of imprecise meaning and definition used frequently in allegations by persons with delusional beliefs about themselves and those around them. the targeting by unknown parties of Judge Magnus Olsson, which planted nude images on his social media to facilitate his false attempted discreditation by and his harassment by an uncooperative and unreasonably demanding former Judge Lena Pu. Although we all received personal comments from Bobbi about legal matters, since she is not knowledgeable about law or about the structure of Tribunals, we don't generally take them seriously precisely for that particular reason. That is why until we are able to verify whether a loose comment about a Tribunal of Conscience is a fact, we should not render it credible.

Even last week, we had discussed that if Bobbi had doubts about the Tribunal, after we had decided that Bobbi would be the first Cybertorture case there, and she agreed and was pleased about it, she should make up her mind whether she would be the first plaintiff. She never indicated that she did not intend to be, and we were waiting for her to answer your questionnaire and write her 3-page introduction for it. She told me that she was working on it.

Jax even reported to us and Magnus at a meeting that some people whom Bobbi knew had insinuated that Magnus was a "perp" because his website was "redirected" to other countries. And I said, that would make him a victim of hacking, and to believe he would do something like that to himself was absurd. These criminals can easily see what the public website says, they do not need to "redirect" it. And we do know that Wordpress is often

hacked. Magnus asked me if there was some kind of psychological problem there, and I replied that I believed that it could be, since a lot of T.I.s were inclined to believe that most people are perps. And then Jax told us at the public meeting that she would never let anyone convince her that Magnus and Alfred were perps. (...) Thus, neither Jax nor any of us took those allegations seriously and we just dismissed them as immature.

Yesterday on the phone I informed you about the other Tribunal of Conscience of Natural and Common Law in London, and which is housed in the prestigious Houses of Parliament in London with support from the British Government, and that it appointed William Binney as one of its Judges. I told you that two years ago Derrick Robinson prepared a group of T.I.s to present their testimony before that Tribunal and one of the impressive testimonies was of T.I. Mariana Maritato, and you could see on the video the question and answer session with the Judges ! I told you that I believed that these Tribunals have merit, and that it would be very premature to dismiss them because they are different from courts of law in the United States.

Neither Jax nor you have a right to invoke the other unprovoked hostility towards Alfred from Marten when non-stop he demanded "proof" that the Royal Family was involved in Coronavirus issues. It was crazy, he lost control and it showed a lack of respect and civility. I thought we were over craziness after that episode.

It would not be mature or professional to form teams to gang up against a victim of unprovoked hostility. There was nothing in our meeting that had provoked the incident of aggression, and made us break the rule of polite behavior amongst us. It was uncalled for and unprofessional.

I am glad that in my 25 years at the UN I never witnessed unprovoked hostility because professional people practice self-control in a civilized fashion.

I would like to reassure Alfred that Jack did not deliberately withhold Bobbi's memorandum. We had all dismissed it as not serious due to the fact that she is not versed in law, and what she implied did not make sense to me, and she continued showing interest in her case heard before the Tribunal. We were waiting for her to answer the questionnaire and write her 3-page introduction.
